1.2 YAC (YARD ADJUSTMENT CHARGE)

Change of Vessel (COV) (applies whenever a container is requested to be loaded onto another vessel than the one requested at the time of booking)	EUR 60 / container
Change of Port (COP) (applies whenever a container has to be loaded for another destination than the one requested in the booking)	EUR 60 / container
Change of Weight (COW) (applies whenever the actual weight differs from the weight in the booking request with more than 1,000kg and if the weight class of the container changes)	EUR 60 / container

No COW applies when the difference between Load List Weight and Booking Weight is less than 1,000kg, even if both weights belong to a different weight class.

- Class 1: 0 - 17,999 kg
- Class 2: 18,000 - 23,999 kg
- Class 3: 24,000 kg or more

YAC is applicable for each change (COV, COP, COW) made after the full container has been delivered to the terminal, even if multiple changes may have been submitted in the same instruction. Before this, updates (via EDI/E-portal) on Vessel, Destination or Weight can be submitted without causing YAC.

2. CONTAINER CLEANING

Carrier owned equipment must be returned as prescribed to the assigned container depot. All equipment must be returned without lashing material, labels, or any debris inside the unit. Before the container is returned empty the unit must be cleaned and brushed from the inside. In case the unit is not returned back in sound condition, cleaning charges will be invoiced to the freight payer. WEC Lines reserves the right to apply additional charges in case of any pollution. Damage to container will be charged according to the interchange report or official repair estimate including additional moves on the depot or terminal.

7. DEMURRAGE & DETENTION COMBINED

Demurrage & Detention Combined: is the charge related to the use of container only, the Merchant party is responsible for the costs that are incurred after the agreed free time, when Demurrage and Detention is combined into one single period.

7.1 EXPORT DEMURRAGE & DETENTION COMBINED

Export Demurrage & Detention Combined: period starting from "gate out" empty container at the assigned depot or terminal till full container loaded on board of the vessel.

8. STORAGE

Storage: concerns a compensation for utilizing the (inland) terminal facilities beyond the agreed amount of free time. Storage is applicable for both carrier and shippers owned equipment, unless otherwise stated.

8.1 EXPORT STORAGE

Export Storage: period starting from "gate in" full container at the assigned (inland) terminal till full container loaded on board of the vessel.
